#### **MINUTES**

Board of Directors July 19, 2022

### SUBJECT TO APPROVAL

1. The meeting was called to order with proper social distancing among everyone and with accommodation for the public through the use of Zoom Meetings at 9:00 A.M. Board President Pete Neal called the meeting to order and the Pledge of Allegiance was recited.

### 3. Consent Items

Mr. McKinney made a motion to approve Consent Items 3.1 and 3.2. Mr. Dashner seconded; motion passed 4-0 (AYES: Clemens, Dashner, Neal, McKinney; ABSENT: Barr).

#### 4. COMMITTEE REPORTS

- 4.2. Personnel/Safety Committee (Directors Dashner & McKinney)
- 4.2.1. **Recognition:** Volunteer Firefighter Jeff Gardner
  President Neal moved this item forward in the agenda so the honoree could leave the meeting early if he liked. Chief Mike Johnson reported that EPFD Volunteer

Jeff Gardner had recently been honored by Central Calaveras Fire District and described briefly the medical incident that Volunteer Jeff Gardner which resulted in a life-saving intervention. [Mike Barr joined the meeting.] Chief Johnson noted the volunteerism exhibited by Jeff Gardner and then read the Letter of Appreciation which was being presented to Jeff Gardner.

## [plaque]

Chief Johnson then presented the plaque to Jeff Gardner. Jeff Gardner then expressed his thanks for the honor and remarked that he was happy to live in the Ebbetts Pass Fire District and thanked the Board for their work in having well-trained medics and the crew as it was a pleasure working with them.

## 4.1. Finance Committee (Directors Dashner & Barr)

4.,1.2. End of Fiscal Year 2021-22 Intra-Account Budget Transfer Chief Johnson reported that Cheryl Howard had prepared the 2021-22 year end intra-account transport for Board approval and, correspondingly, had prepared the financial reports to match so the overages were taken care of. Mr. Barr made a motion to approve the Intra-Account Budget Transfer for the End of Fiscal Year 2021-22 as presented. Mr. Dashner seconded; motion passed 5-0 (AYES: Barr, Clemens, Dashner, Neal, McKinney).

- 4.3. <u>Fire Prevention Committee (Directors Clemens & Neal)</u>
  Chief Johnson presented a report from Joan Lark regarding lot inspection activities.
- 4.4. <u>Apparatus/Equipment Committee (Directors McKinney & Neal)</u>
  Chief Johnson reported the engine had arrived in Sacramento and was undergoing dealer prep at Golden State Fire Apparatus. He reported recent service on the newest ambulance. He also reported work being done on the Quantum engine to fix a fuel leak.

#### 5. Scheduled Items

- 5.1. Fire Districts Association of California: Consolidation of EBA and FASIS Programs
  Chief Johnson noted this had been included for the Board's information regarding
  the FDAC Employee Benefits Administration (EBA) and the Fire Agencies Self
  Insurance System (FASIS). He added that EPFD participates in the EBA for dental,
  vision and life group insurances while EPFD obtains its worker's compensation
  from the Special Districts Risk Management Authority (SDRMA).
- 5.2. <u>Health Management Associates: Independent Contractor/Consulting Agreement for Managed Care Intergovernmental Transfers</u>

Chief Johnson reported that the District has been utilizing Health Management Associates (HMA) for IGT consultation and, as things have been changing in the PP-GEMT, HMA has offered to keep EPFD abreast of all things happening in that arena. He recommended that the Board approve the contract. Mr. Dashner made a

motion to approve the contract and authorize the Fire Chief to sign it. Mr. Barr seconded; motion passed 5-0 (AYES: Barr, Clemens, Dashner, Neal, McKinney).

## 5.3. <u>CalPERS: Unfunded Accrued Liability</u>

Chief Johnson noted that CalPERS had determined the annual payment toward the District's Unfunded Accrued Liability (UAL) to be \$582 for the PEPRA-Safety Plan, \$12,320 for the Classic-Safety Plan, and \$461 for the Classic-Misc. Plan. The total of \$13,363 could be paid lump sum this month or monthly payments. Mr. Barr made a motion to pay the \$13,363 total for CalPERS UAL by the end of July. Mr. McKinney seconded; motion passed 5-0 (AYES: Barr, Clemens, Dashner, Neal, McKinney).

## 5.4. SDRMA: 2022-23 Workers Compensation Renewal

Chief Johnson noted that the annual Credit Incentive Program (CIP) discounts were significant and the Board member attendance at the Safety Meeting each year helped greatly. He reported that the annual worker's compensation premium was a total of \$108,528 this year. Mr. McKinney made a motion to pay the full amount of the worker's compensation premium at the beginning the fiscal year. Mr. Barr seconded; motion passed 5-0 (AYES: Barr, Clemens, Dashner, Neal, McKinney).

#### 5.5. SDRMA: 2022-23 Healthcare Premium

Chief Johnson reported the premiums had increased 9% from the previous year and noted that James Crabtree was actively looking for other plans and the District was hoping to absorb the increase.

## 5.6. Policy Update

Battalion Chief O'Donnell explained some of the policy attempt at cleaning up the vacation coverage process. Chief Johnson asked to table this discussion and the Board members concurred.

#### 5.7. CFCA/CPFF: Fallen Firefighters Memorial Ceremony

Chief Johnson reported that Brian Dickson was to be included among the annual tribute to the firefighter who have made the ultimate sacrifice in service within California. He would be attending the ceremony on July 30<sup>th</sup>.

## 6. REPORTS

## 6.1. Administrative Report

Chief Johnson reported the District had begun the testing process for Firefighter-Paramedic Kyle Salyer and hoped he would begin work in mid August. He added that Alex Baker was on track to be a paramedic in mid January.

Chief Johnson reported the information had been submitted to ISO for their review and rating. He thanked the administrative staff for their assistance with the heavy lifting of information for ISO re-evaluation.

**Board of Directors Minutes** 

Chief Johnson reported on his recent virtual meeting with Representative Tom McClintock's staff regarding the land requested for replacement of Station 3. He added that the next step is preparation of a proposal to be sent with much detail.

Chief Johnson noted that Mr. Clemens and Mr. McKinney were both up for election this year with registration at the Elections Office between July 18 through August 12, 2022.

## 6.2. Legislative Report

Chief Johnson reported that it was current the summer session with no activity.

## 6.3. Administrative - EMS

Chief Johnson noted that Mountain EMS Agency was to be out of their Modesto office by August 1 and would be moving into an office in Copperopolis.

Directive Letter: Longevity Credit Calculations for Volunteer Time

Local 3581 and the Ebbetts Pass Board of Directors has agreed to provide longevity pay beginning on the 17<sup>th</sup> year of Ebbetts Pass Fire District service according to the Memorandum of Agreement signed in 2022. Volunteer time served to the District is specified as credible time at a rate of "1 year of volunteerism equal to 6-months credit." This Directive Letter's intent is to further define how the District's Administration shall calculate various forms of volunteer work for credit:

#### Volunteer credit time shall:

- Be counted if a member is considered "active."
- Administration shall determine the appropriate criteria for "active" volunteer status based on the era of agency affiliation. Example: Drill attendance, call response, and agency event involvement of the era deemed "active" shall receive credit.
- Credit shall be granted for partial active years down to 6-month increments (example: Active volunteer for 6 months out of one year's time equals 3-months credit for longevity. A full 12- months active status equals 6-months credit for longevity).
- Sleeper Program and Intern Program is credible time and considered "volunteer" status and computed as stated above.

#### Volunteer credit time shall not be:

- Double accrued if in multiple creditable programs. Example: If you are an Intern and a Volunteer on the off days.
- Credit for Per-Diem cover or short-term back-fill assignments.
- Credit for Cadet time.
- Volunteering at any other agency.

In recognition of the substantial contributions made by employees of the fire district, effective **July 1, 2022**, the Ebbetts Pass Fire District shall award Longevity Pay to each eligible employee. Longevity Pay is calculated as a percentage of the employee's base wage and does not include holiday pay nor overtime. Longevity Pay does not compound and shall be paid semi-monthly.

As we've all seen, the fire danger in California has continued to increase and the Truckee area is no exception. California has seen 9 of the 20 most destructive fires in California's recorded history in the last 5 years!

The build-up of dry fuels, a significant drought and more people moving to and visiting the wildland urban interface have led to this extreme fire danger that threatens our community. Many of the visitors to our region don't understand the danger, adding to the risk of an escaped campfire.

Each year the Fire District responds to unattended or improperly extinguished residential campfires that escape the fire ring and start a wildfire. If this happens on a windy day a wildfire could be devastating to our community. That is why the Truckee Fire Protection District is implementing a District-wide ordinance to ban backyard type campfires during fire season.

## EFFECTIVE THIS FIRE SEASON

(Starting in June)

- No wood or charcoal fires
- Report illegal fires by calling 911
- Fire season usually runs from June -November

\*PLEASE NOTE - The fire ban does not include gas appliances like gas BBQ's, gas fire pits, pellet burning devices.

Campgrounds and Day-use picnic areas are exempt.

# FREQUENTLY ASKED QUESTIONS (FAQ)

#### What is banned?

Residential campfires/bonfires that burn anything other than gas and BBQ's that burn solid fuel like charcoal briquettes, wood or lump charcoal including the Big Green Egg type.

### What is allowed?

Gas campfires, gas portable fire pits, gas BBQ's, pellet burning devices.

## Who is exempt?

Designated campgrounds and day-use picnic areas, private campgrounds and community picnic areas with a valid permit, outdoor special event/commercial cooking operations with a valid permit.

## Will the ban start when Calfire announces fire season for the entire state?

Yes, typically starting in June and ending after we get significant moisture, usually in November.

## Can people use a briquette fuel-based smoker?

No, the issue being that there are briquettes being used and there still exists a risk of improper disposal of charcoal remnants.

Can people use a wood pellet fuel-based BBQ/smoker? Yes, pellet burning devices are well contained and fully consumed to ash with no super-heated particles remaining that could start a fire after disposal.

## Can people add wood shavings, like apple wood and other types you can buy for added flavoring, to a smoker or gas grill?

No, the addition of wood shavings will present a similar risk of incomplete combustion and improper disposal that can start a wildfire.

## Would the district consider issuing briquette BBQ permits to individual residents?

No, with over 15,000 residential structures in the district, there is no logistical/financial way we could inspect, issue, or enforce permits of that magnitude.

## Will permits be issued for picnic areas and special events/commercial cooking operations that use briquette/wood BBQ's?

Yes, these operations will be inspected for safe practices and issued a permit with specific operating guidelines.

#### Cal OES Form 130 Instructions

A Designation of Applicant's Agent Resolution for Non-State Agencies is required of all Applicants to be eligible to receive funding. A new resolution must be submitted if a previously submitted resolution is older than three (3) years from the last date of approval, is invalid, or has not been submitted.

When completing the Cal OES Form 130, Applicants should fill in the blanks on pages 1 and 2. The blanks are to be filled in as follows:

### **Resolution Section:**

**Governing Body**: This is the group responsible for appointing and approving the Authorized Agents.

Examples include: Board of Directors, City Council, Board of Supervisors, Board of Education, etc.

**Name of Applicant**: The public entity established under the laws of the State of California.

Examples include: School District, Office of Education, City, County or Non-profit agency that has applied for the grant, such as: City of San Diego, Sacramento County, Burbank Unified School District, Napa County Office of Education, University Southern California.

**Authorized Agent**: These are the individuals that are authorized by the Governing Body to engage with the Federal Emergency Management Agency and the California Governor's Office of Emergency Services regarding grants for which they have applied. There are two ways of completing this section:

- 1. Titles Only: The titles of the Authorized Agents should be entered here, not their names. This allows the document to remain valid if an Authorized Agent leaves the position and is replaced by another individual. If "Titles Only" is the chosen method, this document must be accompanied by either a cover letter naming the Authorized Agents by name and title, or the Cal OES AA Names document. The supporting document can be completed by any authorized person within the Agency (e.g., administrative assistant, the Authorized Agent, secretary to the Director). It does not require the Governing Body's signature.
- 2. Names and Titles: If the Governing Body so chooses, the names and titles of the Authorized Agents would be listed. A new Cal OES Form 130 will be required if any of the Authorized Agents are replaced, leave the position listed on the document, or their title changes.

## STATE OF CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES Cal OES 130 - Instructions

Checking Universal or Disaster-Specific Box: A Universal resolution is effective for all past disasters and for those declared up to three (3) years following the date of approval. Upon expiration it is no longer effective for new disasters, but it remains in effect for disasters declared prior to expiration. It remains effective until the disaster goes through closeout unless it is superseded by a newer resolution.

**Governing Body Representative**: These are the names and titles of the approving Board Members.

Examples include: Chairman of the Board, Director, Superintendent, etc. The names and titles **cannot** be one of the designated Authorized Agents. A minimum of three (3) approving board members must be listed. If less than three are present, meeting minutes must be attached in order to verify a quorum was met.

### **Certification Section:**

Name and Title: This is the individual in attendance who recorded the creation and approval of this resolution.

Examples include: City Clerk, Secretary to the Board of Directors, County Clerk, etc. This person **cannot** be one of the designated Authorized Agents or Approving Board Member. If a person holds two positions (such as City Manager and Secretary to the Board) and the City Manager is to be listed as an Authorized Agent, then that person could sign the document as Secretary to the Board (not City Manager) to eliminate "Self-Certification."





#### Purpose and Scope

The purpose of this policy is to define guidelines for the accrual and use of Compensatory Time Off.

- O1. Employees hired under the current (2006) version of the Memorandum of Understanding between the Ebbetts Pass Fire Protection District and Ebbetts Pass Firefighter's Local #3581 may elect to accrue and maintain a maximum of 240 hours of Compensatory Time Off in lieu of cash payment for overtime hours worked.
  - Employees hired after July 1, 2008, may elect to accrue and maintain a maximum 96 hours of CTO.
- 02. Administrative employees who meet the FLSA exemption from overtime criteria are not allowed to accrue CTO.
- 03. For record keeping purposes, CTO hours represent hours previously earned at 1.5T which have been converted to straight time.
- 04. Effective January 1, 2007, under the guidelines outlined under Policy No. 6110.06. below, employees assigned to shift work are allowed the utilize a maximum of 240 hours (10-24 hour shifts) of CTO per calendar year and must be taken in minimum 12-hour blocks of time.
- 05. Effective January 1, 2006, under the guidelines outlined in Policy No. 6110.06. below, employees assigned to a 40-hour per week work schedule are allowed to utilize 80 hours (8-8 hour days) of CTO per calendar year and must be taken in minimum 8-hour blocks of time.
- 06. Requests for scheduled shift vacancy including CTO shall be submitted at least 14 days in advance. Requests shall be approved by the Fire Chief with reasonable regard for the desires of the employee insofar as they are consistent with the needs of the District.

  Standard approval shall require back-fill employees to sign-up for the shifts made vacant by the CTO request.
- 0607. Employees may utilize CTO to take time off from work for any reason, however, the Fire Chief or his/her designee shall have full discretion to establish guidelines and procedures for processing and authorizing employee request for utilization of CTO and may deny requests to utilize CTO if established guidelines are not met or followed. Such guidelines Policy 6110 Page 1 of 2

and procedures may included, but are not necessarily limited to:

- •CTO request notification time frames: 21-14 days
- •Established procedures for filling shift vacancies
- •Availability of qualified relief
- •Maintenance and affect on minimum staffing levels
- •The absence of the employee does not cause a hardship on the District
- 07. Except upon termination of employment or retirement, cash payments for time accrued as CTO shall not be allowed without approval of the Board.
- 08. Upon request, and with the approval of the Fire Chief or his/her designee, an employee may be allowed to utilize more than 240 hours per year for reasons having to do with family emergencies or special circumstances.
- 09. Without District approval, accrued CTO time may not be transferred (donated) from one employee to another employee.

- 01. Each permanent full-time employee shall be entitled to an annual paid vacation. No employee shall be entitled to utilize accrued vacation time until he/she has been in District service for at least 12 months.
  - 01.1. The Board of Directors authorizes the Fire Chief the discretion to waive the required 12 months of service time for employees who have become permanent full-time and who were previously temporary part-time, temporary full-time or permanent part-time.
- 02. With sufficient notification and so long as it does not place a burden on District operations, personnel shall be allowed to take vacation time in any increments of time.
- 03. Requests for vacation scheduled shift vacancy including vacation shall be submitted at least 21-14 days in advance. Requests shall be approved by the Fire Chief with reasonable regard for the desires of the employee insofar as they are consistent with the needs of the District. Standard approval shall require back-fill employees to sign-up for the shifts made vacant by the vacation request.
- 04. Requests for vacation submitted between January 1 and January 31 of each calendar year shall be honored by seniority.
- 06. Paid vacation time for 24-hour shift personnel shall accrue as follows:

Upon hire and less than 5 years of service: 9.33 hours/month (112 hours/year) (Cap 224)
Begin at 5 years of service and less than 10 years of service: 14.0 hours/month (168 hours/year) (Cap 336)
Begin at 10 years of service and less than 15 years of service: 18.67 hours/month (224 hours/year) (Cap 448)
Begin at 15 years of service: 20 hours/month (240 hours/year) (Cap 480)

07. Paid vacation time for 8-hour-per-day personnel shall accrue monthly at a rate equal to:

Upon hire and less than 5 years of service: 10 working days per year (Cap 160)
Begin at 5 years of service and less than 10 years of service: 15 working days per year (Cap 240)
Begin at 10 years of service and less than 15 years of service: 20 working days per year (Cap 320)
Begin at 15 years of service: 22 working days per year (Cap 352)

08. Employees may not accrue more than two years of <u>accrued</u> vacation time based upon their respective time in service.

- 08.1. Employees shall be allowed a 30-day "grace" period to schedule vacation upon reaching their designated vacation cap.
- 09. Upon separation from service, retirement, or death, employees, and in the case of death the spouse of the employee, shall be paid for 100% of unused vacation time at the current hourly rate for their rank and step.
- 10. Cash payments for accrued vacation time, with the exception of separation from service, retirement or death, shall not be allowed.

FIRE Legislative Report – Week Ending 08/05/2022

On Monday, the Legislature returned to the Capitol to complete their remaining work for the 2021-22 Session. This week, activities were dominated by the Senate and Assembly Appropriations Committees hearing hundreds of bills, with most referred to their Suspense Files. The Suspense Files are scheduled to be taken up next Thursday. The measures of interest sent to the Suspense File include:

Assembly Bill 267 (Valladares) would extend the sunset date to Jan. 1, 2026, for the exemption from CEQA for prescribed fire projects, vegetation management and fuel reduction undertaken on federal lands.

Assembly Bill 622 (Rodriguez) would require the State Fire Marshal to establish training standards for peer-to-peer suicide prevention programming for firefighters.

Assembly Bill 1154 (Patterson) would exempt from CEQA until Jan. 1, 2029, egress route projects undertaken by public entities to improve emergency evacuation from subdivisions.

Assembly Bill 1640 (Ward) would authorize the formation of regional climate adaptation and resilience action plans.

Assembly Bill 1648 (Maienschein) would establish a kennel owner to submit an animal evacuation plan to any city or county that requires a license or permit.

Assembly Bill 1942 (Muratsuchi) would require instruction by community college districts under service agreements with public safety agencies to be funded under the apportionment formula used for instruction in career development and college preparation programs.

Assembly Bill 2477 (Rodriguez) would require Cal OES to adopt minimum operating standards for private sector companies that provide emergency alert and warning services for local agencies.

Assembly 2645 (Rodriguez) would require counties to ensure community resiliency centers serve as a resource during disasters, including extreme heat events.

Assembly Bill 2648 (Wilson) would extend the sunset date of the Emergency Medical Air Transportation Act from July 1, 2024, to July 1, 2025, without extending the assessment of penalties beyond the current date of Dec. 31, 2022.

Assembly Bill 2749 (Quirk-Silva) establishes streamlined requirements for the federal funding account (FFA) within the California Advanced Services Fund (CASF).

Senate Bill 450 (Hertzberg) would establish Cal OES to be the and administrator of the Special District Fire Response Fund approved by the voters in Proposition 19 in November of 2020.

Senate Bill 884 9McGuire) would require the PUC to establish an expedited optional utility distribution infrastructure undergrounding program.

Senate Bill 926 (Dodd) would establish the Prescribed Fire Liability Pilot Program to support coverage for losses from permitted prescribed fires by individuals and nonprofits and establishes a Fund to receive a \$20 million appropriation.

Senate Bill 936 (Glazer) would establish a forestry training center in Northern California to provide job readiness for entry level vegetation management positions for formerly incarcerated individuals.

Senate Bill 1338 (Umberg) would create the Community Assistance, Recovery and Empowerment (CARE) program to allow petitions to court to provide for supervision and treatment of individuals living on the streets who suffer from mental disorders.

### Budget

Like last year, the recently enacted State Budget package contained extensive funding for various local fire agency projects at the request of individual legislators; expressly set forth in Assembly Bill 178 (Ting), the list is attached herein for your reference.

Once again, the list underscores how valuable it is to establish and maintain a close working relationship with your own state legislators to provide access to state funding for local programs when the state is experiencing a surplus. Additionally, AB 178 listed some categories that received appropriations, but will require additional legislation in August to flesh out implementation details. These include:

- 1) Wildfire and Forest Resilience \$320 million
- 2) Drought, Response and Resilience \$116.2 million
- 3) Extreme Heat \$150 million
- 4) Nature-based Solutions \$594 million
- 5) Energy Reliability, Relief and Clean Energy Investments \$2.49 billion.
