2. Those users scheduling regular monthly meetings or any other regular use must renew their scheduled use prior to the start of each new calendar year.
3. Before final approval of an application by the Fire Chief, the following documents may be required by the District as a condition of approval: a) Certificate of Insurance, b) Hold Harmless Certificate
4. Rules and Regulations pertaining to the use of District facilities may be obtained from the District Office. All users of District facilities are expected to have a copy of the Rules and Regulations and to abide by those Rules and Regulations.
5. During winter months and snow removal operations, users of District facilities may be asked to move or relocate personal vehicles during snow removal operations. There is no guarantee that parking may be available due to snow removal operations.
6. The undersigned agrees to be personally responsible for any damage sustained by the District's buildings or appurtenances thereof, occurring through the occupancy of said building in conjunction with this use request. The undersigned further agrees to conform to all the Rules and Regulations of the Ebbetts Pass Fire District governing the use of District facilities.

When using the Kitchen Facility, please obtain and complete the Facility Clean-Up Checklist (015-00051) following each use. Note: Kitchen Facility use is only for the appliances located in the training room.
